We accomplish our mission in the following ways:

SAFETY

- Coordinated intervention among child abuse professionals to ensure protection of victims of abuse or neglect
- · Secure facility where families feel safe
- Forensic interview services
- Community Education programs

HEALING

- A child- and teen-friendly environment where children can disclose and heal from abuse
- Services such as assistance with rent, food or other basic needs for families facing crisis due to victimization by abuse or neglect
- Comprehensive therapeutic services for victims of child abuse and their non-offending family members
- Medical evaluations and intervention for victims of abuse or neglect provided through Sexual Assault Nurse Examiner (SANE) and medical providers at Children's Health System – Children's Medical Center Plano and other local hospitals

JUSTICE

- Expert court testimony to educate juries on the prevalence and dynamics of abuse and the services provided by Children's Advocacy Centers
- Court preparation for children through the Kids In Court program

FACT SHEET

WHAT IS A CHILDREN'S ADVOCACY CENTER?

- Children's Advocacy Center of Collin County (CACCC) bring all services to abused children under one roof to minimize additional trauma to vulnerable child victims of abuse or neglect in our community.
- Our mission is to provide safety, healing and justice to children victimized by abuse or neglect.
- We coordinate intervention among child welfare professionals to ensure protection of victims and their non-offending family members.

BEFORE CHILDREN'S ADVOCACY CENTERS

- Prior to the inception of the Children's Advocacy
 Center model, efforts to investigate and prosecute child abuse were often duplicated and inefficient.
- In a criminal justice system designed around adults, child victims were revictimized by the system, having to retell their abuse stories to multiple investigators.
- Criminal cases were often weakened by the lack of coordination between agencies.

THE NEED IN COLLIN COUNTY

- By the age of 18, one in four girls and one in six boys will be sexually abused. One in three boys and one in four girls will be physically abused. Only one in 10 will tell.*
- More than 4,800 Collin County children were reported to Child Protective Services as abused or neglected in 2014.
- More than 3,300 clients including children and their non-offending family members – received a core service at CACCC in FY 2013-2014.

THE POWER OF THE TEAM APPROACH

- CACCC utilizes a coordinated response to the investigation, treatment and prosecution of child abuse.
- Working collaboratively with law enforcement and Child Protective Services, services and resources are efficiently leveraged to provide healing to abused children.
- Communication across agencies strengthens criminal cases so that perpetrators can be held accountable, keeping our community safe.

OUR CORE SERVICES

- Forensic Interview a legally justifiable fact-finding interview with a child by a specially trained professional conducted at the request of law enforcement or Child Protective Services designed to allow a child to disclose abuse.
- Community Resources assistance program designed to meet the basic needs of families impacted by abuse.
- Therapy utilizes evidenced-based, trauma-informed interventions to allow child victims and their non-offending family members the chance to heal from abuse.
- Client Care a social work based advocacy program designed to provide a continuum of care for children and families throughout the criminal justice process.

KEY FACTS

- The District Attorney's Crimes Against Children division maintains a 98 percent conviction rate thanks to collaboration across agencies.
- Rated Four Stars by Charity Navigator for four consecutive years, a distinction achieved by just 7 percent of charities across the nation.
- All services are offered to clients at no cost for as long as they need help.
- CACCC relies on funding and support from the community to carry out its mission.
